# The message in a bottle that could save your life

Thanks to Telford Lions Club 1000 special 'message in a bottle' canisters have been donated to Telford & Wrekin Council. The message in a bottle scheme is used across the country and could save your life.

Personal and contact details, medication and next of kin information are all listed in a simple form and popped in a canister that lives in the fridge. In the event of an incident at home, the ambulance service takes the canister with them to the hospital.

A green cross sticker is attached to the fridge and inside of the front door.

The Lions 'message in a bottle' scheme is a simple idea designed to encourage people to keep their personal and medical details on a standard form and in a common location - the fridge.

Whilst it is focused on the more vulnerable people in the community, anyone can have an accident at home, so this scheme can benefit anyone.

The scheme is endorsed by the emergency services. The 'message in a bottle' will save the emergency services valuable time identifying you and your emergency contacts. By telling whether you have special medication or allergies, it is a potential lifesaver and provides peace of mind to users and their friends and families.

Cllr Jacqui Seymour, Cabinet Member for Adult and Consumer Care, said: "I have actually used this system personally for some time now. As I live

alone, it is a great comfort to me to know that, in the event of an emergency, someone would know who to contact."

Telford Lions Club presented the canisters to the Council's Falls Prevention Team in Adult and Consumer Care and these will be available soon from your occupational therapist, health visitor (for the elderly) and Age Concern in Telford.

The Council's Falls Prevention Team links into the borough's Falls Prevention Group and the Accident Prevention Group. Both network across health, social care, emergency services, the voluntary and private sector. Work is planned with these groups and local pharmacies to promote the use of 'message in a bottle' across Telford and Wrekin, particularly on Falls Prevention Awareness Day on 24th June.

Falls Prevention Awareness Day is a national event to raise awareness of how older people can reduce their risk of falls. To mark the occasion, there will be information stands in Telford Shopping Centre as well as in other local community areas. This year it will include the 'message in a bottle', health, social care and falls prevention exercise information.

Telford Lions are a group of 'like-minded' volunteers who have come together to give something back to

their community. They have one common goal, and that is to help those in need.

Telford Lions was formed in 1969 with help from the then established Lions Club of Shrewsbury.

It has met twice a month since and has, through its various activities, raised in excess of £350,000.

Approximately 90% of this money has been spent locally, and the remaining 10% spent through its connections to the International Association of Lions Clubs.

# Home from Hospital We can take the worry out of going home

Everyone's heard of the Red Cross, but how many people know about the work that we do in the local community? One example is the Home from Hospital service, which operates in your area and throughout Telford & Wrekin, providing practical support to patients when they first return home.

Going home after a stay in hospital is not always easy, but there are trained Red Cross volunteers who can help. The volunteers complement the help which Social and Community Health workers may provide, and are able to assist patients to regain independence through a service tailored to specific individual needs.

Volunteers can help with shopping, collecting prescriptions, transport to doctors or hospital appointments. Being unable to get out and about can be quite difficult to deal with and sometimes all that is needed is for a volunteer to pop in for company, a chat and just to pass the time of day. All aimed at encouraging a return to independent living.

This extra support can be for up to six weeks after discharge from hospital, and people using the service have said that it "may have been instrumental in my early discharge from hospital", and "the volunteer was very kind and helpful" and "seemed to be like one of the family coming in".

Many people who benefit from the service are referred by the hospital social work team or ward staff, although others contact the service directly to ask for help. The service is available to all residents of the borough, whichever hospital they are discharged from.

We are pleased to say that our service is growing, so we also have opportunities for new volunteers to join. If you are a caring person, enjoy meeting people, and have an hour or two a week to spare, we would like to hear from you. The time commitment is very flexible, volunteers' expenses are paid and training is provided.

- Able to be independent and impartial at all times.

In return for your work, you would have training and support to help you. As well as the opportunity to contribute to a vital part of the Council's work, more importantly you can help make recommendations to the Council's Cabinet, and other public services such as the NHS, on how local people can get better services.



# Police Constable 1776 Duncan White – Local Beat Manager, Muxton

I joined the police service as police cadet in 1978 serving at Droitwich and Evesham. After completion of training I joined the regulars at the age of 18 yrs and was posted to Telford Division working out of the old Malinslee House Police station (TDC building) at the Town Centre on uniformed foot patrols and then panda patrol of the 'South Telford' area.

In 1982 I was appointed as the first beat manager for the Overdale, Lawley and Dawley Bank area on both foot and cycle patrol and was in this role for 2 years. I was then posted to rural response at Shifnal Police station.

I have worked in numerous departments throughout the Force which includes time spent in plain clothes and CID at Malinsgate working on intelligence and interviewing convicted criminals in prison.



I have qualified as an FA Football coach subsequently helping to run many local junior teams in the area, going to coach each summer in the USA and also involved with Telford United Youth Teams and then also with Wolves and WBA in numerous scouting and coaching capacities. In 1994 I was awarded the High Sheriffs of Shropshire award for contribution to the community through football and community work.

I was awarded the Chief Constables Commendation for work nationally and support to others including involvement in the Public Inquiry into Harold Shipman on the national picture and role of the chemist inspection officer and subsequent Dept of Health consultation committee to review legislation and procedure.

In 2005 I was awarded ACPO Commendation for continuing work in field with National Association of Chemist Inspection Officers.

I was appointed on secondment to work with the Healthcare Commission in London as the National Police Liaison Manager as a Detective Sgt working with ACPO and police forces around the country and in N/Ireland as an advisor on the new legislation and regulations for controlled drugs post Shipman - touring the UK giving presentations and advice to all partner agencies and organising training and conferences for police and partner agencies.



#### **Decisions**

Together with the above financial account (which is available in more detail from LDPC Parish Clerk), this article has hopefully covered most of the issues relevant to informed consideration of any independence proposals for Lilleshall.

It is for Lilleshall electors to decide upon their personal priorities and preferences and whether they would wish to support any petition for an independent Lilleshall Parish Council.

LDPC is neutral, but its councillors are free to act as individuals within the Code of Conduct. LDPC has no control over whether any new proposals or petition will be raised following this article.



# An Independent Lilleshall Parish Council?

#### **Background**

As a result of a request from some members of the electorate residing in Lilleshall to investigate the possibility of Lilleshall becoming independent from Lilleshall and Donnington Parish Council, it was decided at a Council meeting to provide the residents of Lilleshall, through this newsletter, with enough information to allow each member of the electorate residing there to make their own informed decision on whether they would like an Independent Lilleshall Parish Council or whether to remain as part of Lilleshall and Donnington Parish Council.



#### History

Parish Councils are local authorities first created by statute in 1894 and form the tier of local government closest to the people. It is at this time that Lilleshall Parish Council came into existence but in a much different format from present day Parish Councils. In the 1800s the parish boundary included Donnington, Donnington Wood and Muxton as they were at that time. Until 1914 parish councils were locally opposed, often derided and poor. Nevertheless Parliament from time to time saw fit to increase their functions and it was in this period that they acquired their modern powers in relation to allotments, postal facilities and open spaces. The inconsistent currents of government policy are mainly responsible for the peculiar history of twentieth-century parish administration.

Until the 1970s financial legislation was mostly passed without regard to the interests of the localities. Around 1972, the newly elected government inherited an undertaking to reform local government and it is around this time that the Local Government Act 1972 came into being. This Act is one of the main statutes that governs what a parish council can and cannot do.

Obviously, the changes of parish councils from 1894 to present day has been a long process and this is only a short insight as to how parish councils came into existence.

It was not until 1982 that the name was changed to the present Lilleshall and Donnington Parish Council. This was due to the increased size of Donnington and the representation on the Council.

#### **Creation, Abolition or Alteration of Parishes (England)**

Under the Local Government and Rating Act 1997 section 11, the district or unitary council can be forced to conduct a review if a petition for a new parish is signed by not less than 250 or 10% of local government electors in the area concerned, whichever is the greatest. That is, those people who are shown on the local register of electors as resident within the area of the proposed parish. It is advisable to ensure that there are sufficient signatures so that their number is not in dispute. The petition must clearly define the area of the proposed parish by way of a map, or a written description, which refers to identifiable fixed boundaries. This power extends only to the creation of new parishes and not to reviews of existing parish boundaries.

#### Representation

A parish council in England consists of such number of councillors as may be fixed from time to time by the district or unitary council, not being less than five. Councillors can be people that not only reside or work within the parish but live within three miles of the boundary.

Lilleshall and Donnington Parish Council currently has 15 councillors (two of which are also Borough Councillors). The Parish Council is split into three wards. These are Donnington, Lilleshall and Muxton and are represented in the following way:

Donnington has 6 councillors roughly equating to 1 councillor per 754 electors. Lilleshall has 3 councillors roughly equating to 1 councillor per 331 electors. Muxton has 6 councillors roughly equating to 1 councillor per 773 electors.

#### Comparison

The following is a comparison of Lilleshall and Donnington Parish Council (LDPC) as it stands and what responsibilities an independent Lilleshall Parish Council (LPC) will/may inherit.

#### **Finance**

Parish Councils are funded by way of a precept which is a demand for a sum of money made to the Borough Council and by income from any service they provide, for example, hire of a community hall. They then use this to provide services to help improve the local community. For ease of calculating the financial effect that this will have on those residing in the parish, the precept is averaged out to the number of "Band D" houses within the parish. That number is provided annually by Telford and Wrekin Council.

Example: For the financial year 2007/2008 the precept was calculated on an average of 4,240 "Band D" houses in the parish. Therefore, the precept of £180,000 divided by 4,240 for the financial year 2007/2008

works out to an average of £42.45 per elector. Those in different Band housing, single occupancy etc will obviously pay less or more depending on each personal circumstance.

There now follows a breakdown of average income and expenditure spent in Lilleshall for 2004, 2005 and 2006. The figures for 2007 have been omitted as they are incomplete, due to the fact that the financial year for a parish council runs from 1st April to 31st March.

Where an exact breakdown cannot be apportioned to Lilleshall (eg employee costs, stationery, insurance etc) it has been decided to calculate the figure to 10% which reflects the percentage of population that Lilleshall has compared with the total population figure for this Parish Council. The figures have been taken from the computerised accounts and are produced as accurately as is possible:
